## Regular Meeting Minutes December 18, 2019

Vice President Leward Henry called to order the Regular Meeting of the Terrebonne Levee and Conservation District at the TLCD office located at 220 Clendenning Road, Houma, Louisiana, at 5:30 P.M. on December 18, 2019.

Angela Hidalgo led the opening prayer, and Commissioner Henry led the Pledge of Allegiance to the American Flag.

Upon roll call by Angela Hidalgo, Commissioners recorded as present: Butler, Cenac, Chauvin, Daisy, Henry, and Moore. Commissioners Alford and Walker are recorded as absent.

Under Approval of Minutes, there was a motion by Commissioner Daisy, with a second by Commissioner Cenac, to approve the Regular Minutes dated December 9, 2019. The motion passed.

Mr. Dupre asked the board to pass Resolution 19-017 amending and restating Resolution No. 19-012 adopted on November 6, 2019. This is being done on the advice of TLCD's bond counsel Eric LaFleur and John Mayeaux. Motion: Moore, Second: Daisy. The motion passed.

Under Engineering Updates, Philip Chauvin with T. Baker Smith provided an update on the Marmande Canal Structure Project.

David Boudreaux with Delta Coast Consultants provided a report on the HNC Lock Complex Project, mitigation, and the maintenance/rehabilitation projects.
