Regular Meeting Minutes May 15, 2019

Vice President Leward Henry called to order the Regular Meeting of the Terrebonne Levee and Conservation District at the TLCD office located at 220 Clendenning Road, Houma, Louisiana, at 12:05 P.M. on May 15, 2019.

Angela Hidalgo led the opening prayer, and Commissioner Henry led the Pledge of Allegiance to the American Flag.

Upon roll call by Angela Hidalgo, Commissioners recorded as present: Chauvin, Daisy, Henry, Moore, and Walker. Commissioners Alford, Butler, Cenac, and Shaffer are recorded as absent.

Under approval of minutes: Motion: Daisy, Second: Chauvin, to approve the Regular Minutes dated May 6, 2019. The motion passed.

Under Public, there was no one wishing to address the board.

Under Management's Report, Greg Gautreaux provide an update on floodgate maintenance closures.

Under Executive Director's Report, Mr. Dupre asked the board to authorize the quote from GIS Engineering in the amount of \$17,680.35 for work on Bayou Black for the 2019 High River Event. Motion: Moore, Second: Chauvin. The motion passed.

Chairman Moore asked the board to approve the Operating and Engineering Invoices for payment, as presented. Motion: Chauvin, Second: Henry. The motion passed.

Under Engineering Updates, Philip Chauvin with T. Baker Smith reported on the TLCD General Services Agreement and the Marmande Canal Structure.

Mitch Marmande with Delta Coast Consultants, LLC provided updates on the HNC Lock Complex, the Indefinite Embankment Supply & Delivery Project, and other maintenance projects currently underway.
